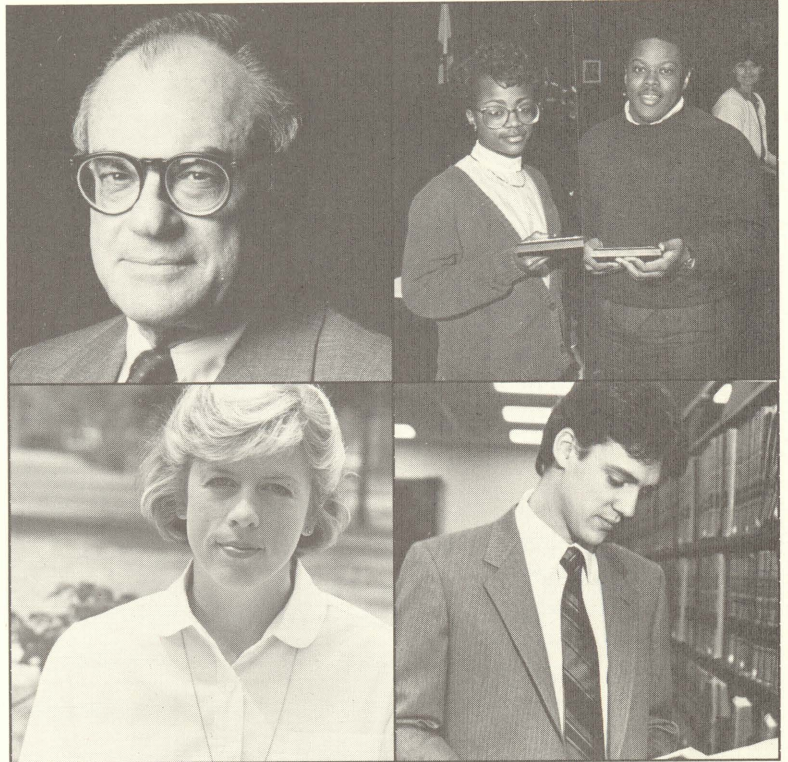

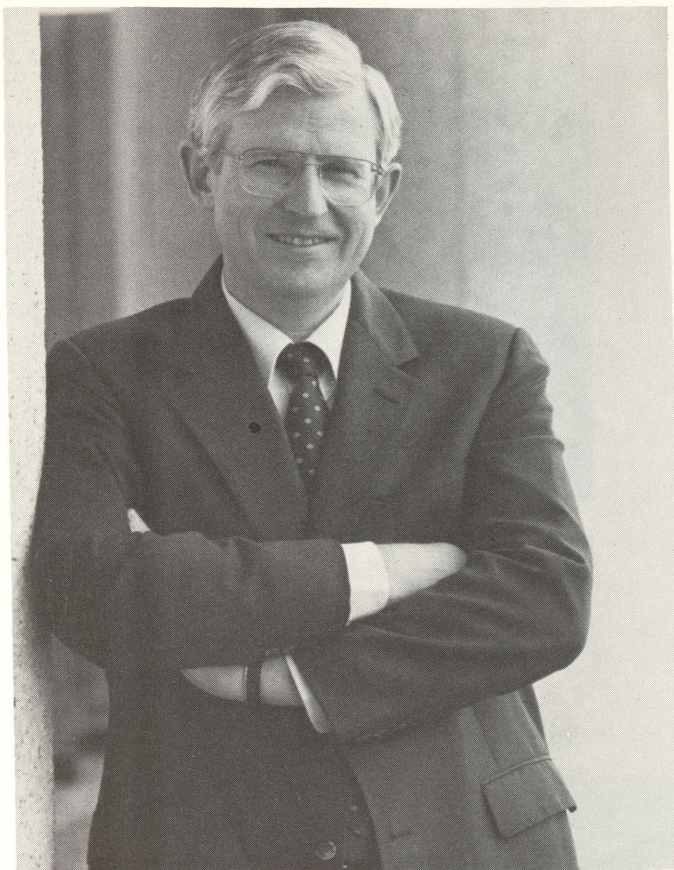

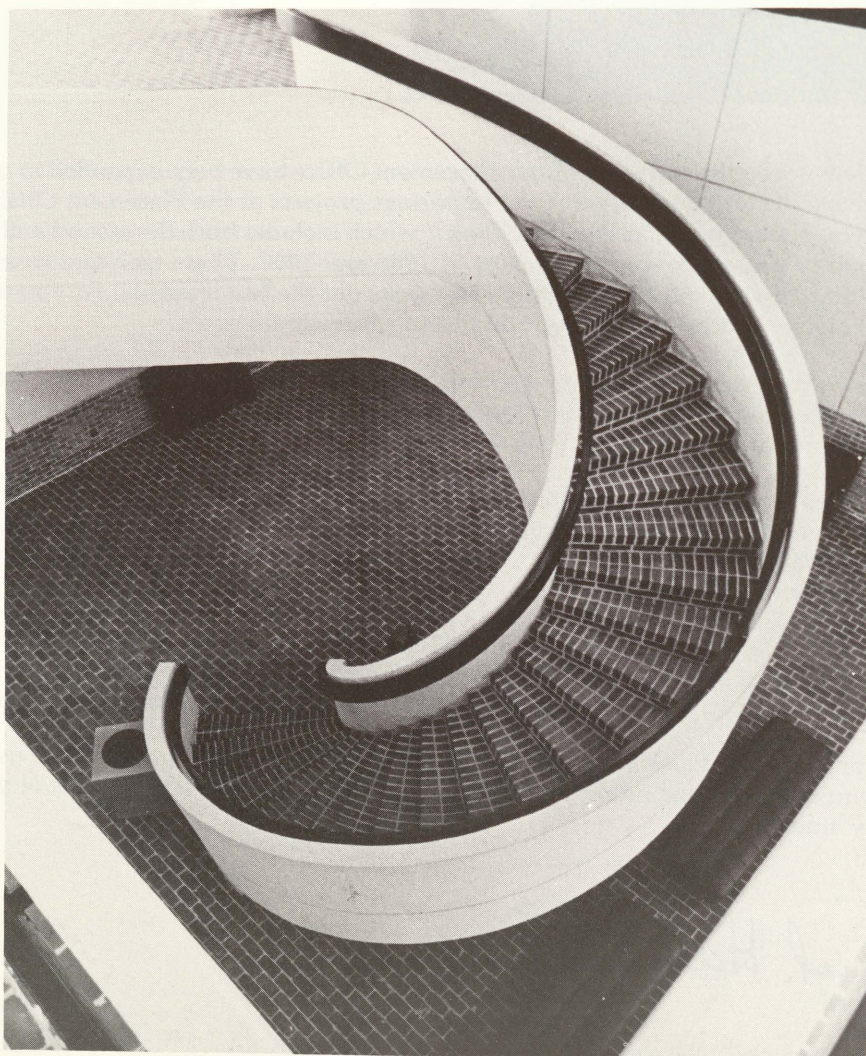

Student Body Profile and Activities

The Law School graduates approximately 165 students per year. Total full-time enrollment for the school year 1986-87 was 466. Over 560 applications from 20 different states and 109 schools were received for the fall of 1986. The 1986-87 entering class of 169 students had a mean average LSAT of 34/48 and a QPA of 3.10/4.0. Approximately 35% of the same class were women and 9% were minorities.

LAW JOURNALS/REVIEW

There are four journals for which students are selected after completion of their first year.

Alabama Law Review: The top seven students of each of two sections of the 1st year class are invited to join, and the top 50% may enter writing competition to complete the Review's selection. The selection is based on composite GPA score and writing competition.

Journal Of The Legal Profession: Membership is selected from the top 15% of the class. This Journal is the nation's first periodical exploring legal ethics and problems confronting the profession.

The American Journal of Tax Policy: Open to students in Taxation and Tax Policy, this Journal is the official publication of the American College of Tax Counsel, an organization composed of distinguished tax lawyers.

Law and Psychology Review: Published by law students at The University of Alabama, this Journal provides a forum for discussion of issues in the law and social sciences. With approximately 500 permanent subscriptions to this Journal, subscribers include academicians and practitioners in all fifty states and abroad.

MOOT COURT

National Moot Court Competition

Third year students are selected by the Campbell Moot Court Board for their outstanding ability in legal research, writing, and oral advocacy. Alabama's teams placed first at the Regional Competition in 1986 and also placed second in the nation for the same year.

John A. Campbell Moot Court Competition

Named in honor of a former Alabama Supreme Court Justice, this competition is open to second year students; final rounds are judged during Law Week.

Trial Advocacy Program

The Trial Advocacy Program makes available four elective courses that give students the opportunity to gain practical experience in the courtroom. Local attorneys add

much to the program by judging trials and critiquing student performances. Student teams compete in two national competitions. Selection is made by competition, with local judges and attorneys selecting the winners.

Jessup International Law Moot Court

This team is comprised of five third-year students who write briefs and act as oral advocates in hypothetical cases before a fictitious International Court of Justice. The 1986-87 team was the champion of the Southeastern Region and won a trophy for having written the best briefs. At the national competition, one of our students was named as the Nation's Best Oral Advocate and another was ranked as the nation's sixth best advocate.

Employment Report on Class of 1986

A survey of 1986 graduates reveals that beginning salaries are up over the previous year. Approximately 80% received more than \$20,000 annually. Graduates entering private practice was 54% which is a 10% increase from 1985. Judicial clerkships remained the same, however, there was a decrease of 4% in graduates entering Business/Corporate practice. The majority of graduates staying in Alabama increased by 10% over 1985, however, graduates remaining in the Southeast remained stable, while those going to "other" areas decreased by 8%. Within 6 months after graduation 83% or more have secured legal employment. Reports from the class of 1987 indicate this percentage will be higher.

Career Planning and Placement Program

The Career Planning and Placement Program is designed to assist all students in their efforts to find employment, whether in traditional legal career areas or in non-traditional areas.

The Placement Office has an excellent Career Resource Center. In addition, seminars are presented on resume writing, interviewing techniques, and job-search techniques that help students refine their job-search skills. Special guest speakers and panel discussions are scheduled as part of the Career Planning/Placement Program.

The office provides numerous opportunities for students and employers to meet and students are encouraged to participate in our four recruiting conferences.

Southeastern Law Placement Consortium (SELP) is composed of eleven Southeastern law schools. Each October students from the eleven schools and employers nationwide meet in Atlanta, Georgia to participate in the largest and most successful cooperative off-campus interviewing program for law firms in the United States.

Gulf Coast Recruiting Conference is designed to provide students interested in working in the Gulf Coast area an opportunity to interview law firms from that region. This conference is held each year in mid-September.

Mid-South Law Placement Consortium is a spring recruiting conference held in Nashville, Tennessee and offers students the opportunity to interview with law firms in the mid-south area, which includes Tennessee, Kentucky, Arkansas, and parts of Georgia, North and South Carolina.

Southeastern Public Interest Job Fair is a fall recruiting conference held in Atlanta, Georgia which provides students employment opportunities with public-interest law employers in the states of Georgia, Alabama, Florida, Kentucky, Mississippi, Tennessee, North and South Carolina.

On-Campus Interviewing offers employers a cost-effective and time-efficient means of interviewing highly-qualified students in

a convenient location during a concentrated time span. The smaller, as well as the larger law firms, benefit from this organized means of interviewing students and fulfilling hiring needs.

Off-Campus Interviewing/Resume Forwarding provides employers who are unable to interview on campus a method of announcing positions available. The Placement Office will post the job description, collect resumes, and forward them to the employer. Employers also may elect to have the student contact them directly.

Alumni Placement provides employers, who are seeking experienced attorneys, the opportunity to list positions available with the Placement Office.

The fall on-campus interview program, SELP, Gulf Coast Conference and Southeastern Public Interest Job Fair are available for second and third year students. The Mid-South Placement Consortium and employers who come to campus in the spring may interview first, second and third year students.
