As the General Counsel and Senior Vice President of the National Shooting Sports Foundation ("NSSF"), the firearms industry's trade association, and an American Bar Association ("ABA") member, I am deeply troubled by today's ABA teleconference and live audio webcast *Gun Regulation and Litigation After Heller*. I am shocked by the overwhelming gun control bias of this panel. Surely you could have an attorney that has litigated Second Amendment cases to participate in the panel to provide a countervailing view. This is not the first time, and sadly I am sure it will not be the last time, that the ABA's anti-gun, anti-Second Amendment bias has been so transparently on display. Nor is this the first time I have raised my concerns on this subject with the ABA.


